#### Public Hearing on the FY 2022-2023 Budget

- **1.** Call Public Hearing to order and establish a quorum Board Chairman Robert Mayer called the Public Hearing to order at 9:00 a.m. and established a quorum
- 2. Open Public Hearing on FY 2022-2026 Budget No members of the Public were present
- **3.** Adjourn Public Hearing on FY 2022-2023 Budget A motion was made by Director Max Howorth to adjourn the Public Hearing with a 2<sup>nd</sup> by Director Erika Campbell. The motion passed unanimously.

- **4.** Call Regular Meeting to Order Board Chairman Robert Mayer called the regular meeting to order at 9:15 a.m.
- 5. Recognize Visitors—Any person or group wishing to speak to the Board on any item on the Agenda will be allowed 5 minutes None Present
- 6. Recognize Pump Installers & Drillers—Any person or group wishing to speak on any item on the Agenda will be allowed 5 minutes None Present
- 7. Water Level and Rainfall Report Technician Sofia Galindo presented rainfall and water level reports for the month of July.
- 8. Action, Discuss, or Consider Approval of Minutes of the July 12, 2022 regular meeting. Campbell made a motion to approve the minutes of the July 12, 2022 regular meeting. The motion was 2<sup>nd</sup> by Howorth. The motion passed unanimously.
- **9.** Action, Discuss, or Consider Approval of Bills and Financial Statements for July 2022. Operations Manager Lana Tolleson reviewed the expenditures and tax receipts for July 2022. Howorth made a motion to approve the July 2022 bills and financial statements. The motion was 2<sup>nd</sup> by Director James Archer and passed unanimously.

The Board reviewed the FY 2020-2021 financial audit provided by Neffendorf & Blocker, P.C. A motion was made by Archer to accept the audit with a  $2^{nd}$  by Howorth. The motion passed unanimously.

14. Action, Discuss or Consider Property Struck Off to the Taxing Jurisdictions for Delinquent Property Taxes. The Property being identified as R100966.

Campbell made a motion to accept the bid of \$300 from Luis Lira for Property #R100966. The motion was 2<sup>nd</sup> by Archer and passed unanimously.

Tolleson presented a Code of Ethics Policy and a Travel Expenditures Policy for the Board to consider. Board members asked that additional policies required by Chapter 36 be presented to the Board for consideration, then all policies sent to the District's Attorney for review.
