13. Action, Discuss or Consider TML Intergovernmental Risk Pool Declaration of Coverage for FY 2021-2022

Archer made a motion to set the District's Errors & Omissions liability limit with TML IRP at \$3,000,000 per occurrence with a \$1,000 deductible per occurance. The motion was 2nd by Howorth and passed unanimously.

14. Consulting Manager's Comments

- a. GMA 7 Allen informed the Board that GMA7 approved the draft of the DFCs at their August meeting and they have been sent to TWDB for administrative review. Upon completion of the review, they will be sent back to the Districts for approval.
- b. Legislative Update Allen noted that the Legislature is currently in the 3rd round of special sessions, with no groundwater legislation on the agenda. Allen and other GMA 7 representatives will be meeting with Senator Perry and Representative Darby's staff in San Angelo next week.
- c. TAGD Groundwater Summit Allen and Galindo attended the Groundwater Summit in San Antonio in person, with Campbell and Tolleson participating virtually. The sessions were very informative and videos of the sessions will be available on the website soon.

a. Update on District Activity –Tolleson shared comments on the Groundwater Summit and updated the Board on preparations for ending FY 2020-2021 and beginning FY 2021-2022.
